TARGETED IMPROVEMENT PLANS

This Targeted Improvement Plan (TIP) is intended to supplement the District and Campus Improvement Plans for KIPP Texas. The Targeted Improvement Plans are only required for schools that have a federal designation of Comprehensive Support and Improvement (CSI). All ten of the schools that are identified as CSI at KIPP Texas are due to the Domain III Closing the Gaps scaled scores during the 2022-2023 school year. The template below is provided to the schools online by TEA and required to be approved by the KIPP Texas Board by February 28, 2025. In addition to the information provided below, all of the schools participated in an Effective Schools Framework (ESF) Diagnostic with the local Education Service Centers (ESCs) in 2024. Finally, each school shared information and received feedback from families on the improvement efforts at the school.

STRATEGY

- Implementation of Open Education Resources or another State Board of Education approved **High Quality Instructional Material**

REALLOCATION OF RESOURCES (TIME, FUNDING, TALENT) TO IMPLEMENT STRATEGY

- We will reallocate time so that district staff can spend more time supporting schools with less experienced teachers.
- We have applied for the LASO Cycle 3 grant to **support math instruction and to support content teams**
- If we do not receive the grant, we will continue to use teacher intensives to show the connection between the Research-Based Instructional Strategies (RBIS) and our curricular products. We will also leverage new support from Amplify Texas and Bluebonnet learning to better support content team planning so that teachers are developed both in their content knowledge and pedagogy. Additionally, we will continue to track curriculum implementation metrics to ensure teachers use high quality instructional materials with fidelity.

STAKEHOLDER ENGAGEMENT

- Our LEA has undergone an **extensive curriculum adoption** process over the last two years. Teachers, assistant principals, school leaders and district leaders will participate in curriculum selection committees through fall 2024 and spring 2025; in January 2025, we will have a curriculum roadshow to allow schools to participate in the selection of 25-26 curriculum in new adoption areas (for high school math and K-12 social studies). Each curriculum choice has a stand alone committee and feedback is solicited at the school level before a final decision is made.
